- IEDC's Annual Meeting was held April 5th. Thank you to speakers Gary Johnson, Paul Bunyan Communications and Mark Phillips, IRRRB. Also, a huge thanks to all of our partners who took time out to help celebrate our 2015 accomplishments. We couldn't do it without you!
- **Connect Itasca** Paul Bunyan Communications is making good progress on their expansion into the Balsam area and has grown the number of committed locations from 1,255 to approximately 1,400. We are working with other providers on a couple of additional broadband expansion projects for Itasca County. The MN Border to Border grant cycle for 2017 starts this fall and we are working with our partners to investigate possible expansion projects.
- Iron Range Regional Rail Initiative IEDC continues to help lead this effort for Itasca County. Discussions have started with the Itasca County Regional Rail Authority. Work continues on potential funding for preengineering work. The team continues to analyze what is the best route for an Itasca County connector from Cohasset to approximately the Coleraine area.
- It takes a village, or, in this case, more than one. Tamara Lowney, APEX, Mark Zimmerman, IEDC, Rob Mattei, City of Grand Rapids, Max Peters, City of Cohasset, Ben DeNucci, Nashwauk, and Tim Johnson, Marcell/ Bigfork, have formed a brainstorming team to research and identify key marketing points to help answer the question, "Why Itasca County?".
- #3 in a series of business and succession planning seminars was held April 26th. Fifteen representatives from 10 local businesses participated in the roundtable format presentation. Speakers for the seminar were Pat Kane from Lefty's Party Tent & Rental and Mark Hawkinson of Hawkinson Construction. Roundtable discussions were led by Mike Andrews, Dennis O'Toole, Bob Palmquist and Brad Zumbaum.
